Facts and figures

- Reach 60.000 children between ages 2,5 4
- Currently 80% of the target group in age 2-3 (preschool and day-care centres)
- Schools:
- Compulsory education: 5 years etc.
- **57%** of the target group in age 4-6 (school) are reached: not all the schools are offering ECEC
- 70% of the children are from migrant families



Basic principles ECEC in the Netherlands

- ECEC is provided by child day care centers, publically funded playgroups and primary schools.
- Targeted ECEC programmes should be offered to:All children at risk of a language deficiency and/or educational disadvantages
- Municipalities receive budget for ECEC (age 2-3):For identification of children, inflow in ECEC and subsidies to preschool and day-care centres.
- Schools receive budget for all children with educational disadvantages (age 4-12)



Quality demands 2-3 years: law 2010

- ECEC offered minimum 10h each week
- Maximum group size: 16
- Staff child-ratio > 1:8
- ECEC staff: Isced 3
- Working with an integral ECEC programme
- Staff has received specific schooling in the field of pre-school education
- Location: preschool or day care centre
- Framework of the Inspectorate
- 360 municipalities, 5300 locations



Results for locations 2011

	Preschool (%) sufficient	School (%) sufficient

D. Pedagogical approach	80	85
E. Educational actions	70	78
F. Development, coaching and care	40	71

Investment

- Arrangements with 37 cities
- Budget € 400 mln. for 2012-2015
- Inspectorate monitors in 2013/2015.
- Preschool/kindergarten
- +/- 30.000 children



- 1) More teachers with a higher degree
- 2) Enhancing teachers language levels
- 3) Parental involvement
- 4) Result-Oriented working methods



Arrangements/indicators

Working in a result-oriented way

- Operating a child monitoring system
- Following up on the child's broad development
- Evaluating and supervising the guidance and care provided
- Evaluating the quality and the results

Partental involvement

- Encouraging activities that stimulate development
- Informing partents about how their children are developing



Monitoring in 2013/2014

Results after 1 year: 15 of 37 reports

- Municipalities are making huge strides at policy level
- Factual indicators are all being achieved
- Progress almost everywere

Most difficult: partental involvement and resultoriented working
